HOMOLOGATION PERIOD CLOSED UNTIL DECEMBER 31st 2024

PROCEDURE FOR WKF KARATEGI APPROVAL

1. The company will communicate the interest of obtaining the "WKF Approved" certification to the WKF official email: wkf@wkf.net
2. The WKF will send a draft of the agreement and a sample of the design required to the interested company.
3. The company will inform the WKF on the acceptance of the final agreement or not. In case it is accepted, all company details and logo must be sent to the WKF to issue the final agreement and logo.
4. The company has to send a karategi model sample for each category (Kumite/Kata) and according to the WKF karategi design (**ANNEX I – II – III**) to the WKF Headquarters for the approval. The models sent can be of any size.
5. After the signature by the WKF President, one of the original signed agreements will be send back to the company as culmination of the karategi homologation process by the WKF.

HOMOLOGATION CONDITIONS

- WKF commits itself, along the period of effectiveness of the homologation contract, and in its scope of action in the five continents, to establish by means of rules the use of the "WKF APPROVED" Brand, in the following terms:
 - a). WKF will allow the use of approved karategi worn by athletes in all kumite and kata categories in official competitions or activities organized by or under the auspices of WKF, except for the WKF competition 2022 Karate1 Premier League.
 - b). No National Federation affiliated to WKF can refuse in their competitions the use of sports items officially approved.
 - c). WKF will communicate to all National Federations affiliated during 2022 the contact details of the suppliers of products officially approved.
 - d). WKF will make available during the effectiveness of this contract an exclusive space in the HOME PAGE of its website, in which will be included the promotional actions listed below:
 - Full commercial address
 - Picture of each homologated karategi model
 - Link with direct access to official web

- e). WKF gives over to the "WKF Approved" Brand its logo for as long as this contract is effective in order that the logo is put into the containers of officially approved items, next to the text "APPROVED".
- f). WKF gives over to the "WKF Approved" Brand its logo for as long as this contract is effective in order that the logo is put into the labels of officially approved items, next to the text "APPROVED".
- The Brand commits itself, in exchange for the stated above, to:
 - a). Maintain the high quality and technical features in the items officially approved, without making any change on them.
 - b). Include WKF logo in all material officially approved so that it can be well and easily seen with the following requirements:
 - 1.- WKF logo must be located on the edge of the seam at the lower part of the jacket.
 - 2.- WKF logo and the word to be printed will be as it is shown next:



Design is attached in annex 1 of this contract.

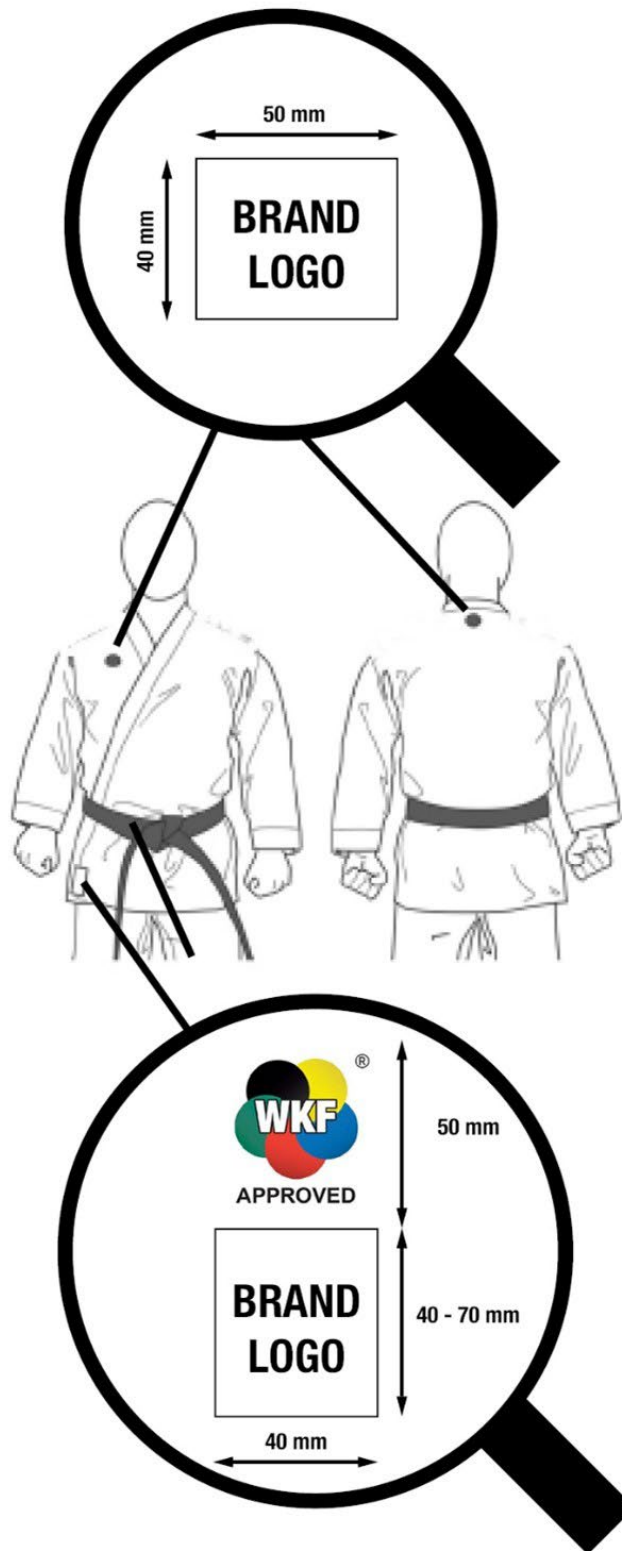
3.- Not put into any other product among theirs either WKF logo or legend "WKF APPROVED".

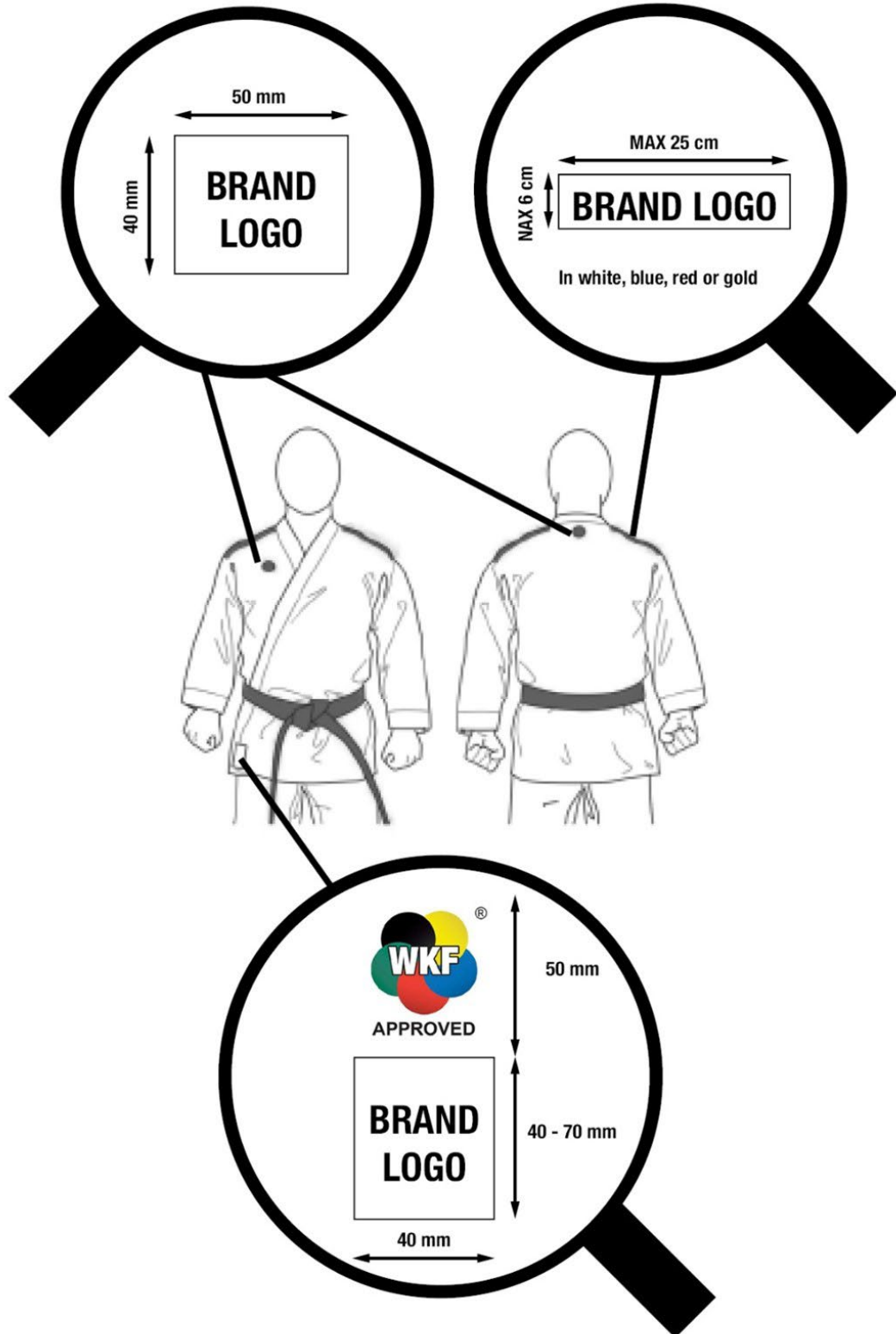
